INTRODUCING THE SKY LAKE FOUNDATION

AS THE TURBINE TURNS

One by one, the twenty-six turbines of the Bluestone Wind Farm were finally powered up last autumn, including the four located on the Sky Lake property. By early December safety testing was completed and the farm officially began producing electricity for the New York State grid. In theory, the power used to write and print this newsletter was generated in Sky Lake's literal airspace.

Thankfully, the turbines have been even quieter than we anticipated and guests have been mesmerized by the rotation of the blades. In addition to electricity, the turbines will also produce revenue for Sky Lake for the 30+ years to come—much of which will be used toward funding capital improvements on site.

STRENGTHENING COLLABORATIONS

In 2019 Upper New York Camp & Retreat Ministries formalized a collaborative agreement between Sky Lake and Susquehanna CRM. The Board of Directors of Susquehanna CRM recently announced the findings of a lengthy study and has submitted a proposal to go before the Susquehanna Annual Conference in June. In overly basic terms, they propose to retain two sites (Camp Penn and Wesley Forest) and strengthen the collaboration with Sky Lake. While Sky Lake will remain fully under Upper New York Annual Conference, we are looking forward to strengthening the long-standing relationship with our friends in Pennsylvania.
